Nightside Studio shall have the right, at its sole discretion, to modify, add or remove any terms or conditions of these Terms of Use without notice or liability to you. Any changes to these Terms of Use shall be effectively immediately following the posting of such changes at Nightside Studio premises. The most recent version of these Terms of Use may always be found at Nightside Studio premises (See Elegance Resident's Picks for Location). These changes generally reflect any changes in policy regarding issues NSS may deem harmful to NSS intellectual property rights and not actual terms of use of the textures inside SL.

You agree to follow all applicable laws regarding the intellectual property rights of Nightside Studio, be it laws of your country, the United States of America, Canada, and/or International Law regarding intellectual property.

What you can do:

-Use these textures in Second Life as applications to your prims/sculpts/meshes to sell inside Second Life with permissions set to either no copy or no transfer

-Use these textures as part of your clothing designs as long as the clothing designs aren't transferred to any other virtual world and as long as the clothing designs are resold with permissions set to either copy or transfer but not both.

-Use these textures as part of your clothing template designs as long as the templates have been flattened to one layer, aren't transferred to any other virtual world.

You agree that you shall not:

- Resell

- Sell

- Give away

- Modify and resell

- Resell any derivative texture with these textures as part of the derivatives composition. This also prohibits the sale of full permission LAYERED clothing texture templates made with these textures as part of the composition. Clothing templates may be created using NSS textures only if the template is flattened into one layer so no layers with NSS textures on can be removed from the whole.

- Include for sale or give away prims/sculpts/mesh with these textures set to modify/copy/transfer permission and included in the contents of scripted prims/mesh/sculpts

- Include for sale or sell prims/mesh/sculpts with these textures applied to them and with prim/mesh/sculpt permissions set to both copy & transfer

- Otherwise distribute or transfer to other Second Life residents
- Transfer, distribute or sell in any of the above mentioned forms to any other virtual world residents
- Upload to any other virtual world for any reason
[Nightside Studio textures are licensed for usage exclusively on the Second Life grid unless extended licensing for usage on other selected grids is purchased. See below.]
- Use Nightside Studio textures to promote or as a part of any organization or activity that unlawful, abusive, threatening, harmful, defamatory, hateful or otherwise objectionable.

Failure to adhere to these terms will result in termination of licensing without no refund.

For Extended Licensing

Nightside Studio will sell licensing on a per set basis at this time, and on a case by case basis, depending on the grid involved and the grid owners/managements intellectual property protection policy. All extended licensing must be purchased through contact with Elegance Resident
