TERMS AND CONDITIONS

License agreement ("User License") between Angel Rae's Textures and you, the user or customer.

Purchase and usage of content from this website and associated stores is conditional upon your agreement to the terms and conditions set out below. If you do not agree to these terms, you must not purchase, download, access or otherwise use any content from Angel Rae's Textures.

The Licensor (Angel Rae's Textures) reserves the right to amend, change, and update this license agreement at any time and without prior notice.

Please do refer back to this license page from time to time. Continued use of content made available from Angel Rae's Textures will constitute your acceptance of any license changes.

LICENSE

Angel Rae's Textures is a co-operative group of digital artists offering content for purchase for private and commercial use to game developers, special effects artists, graphic designers and other professions. The content sold is royalty free and non-exclusive. This means you are not subject to additional payment or royalty fees upon acceptance and purchase of this license and its associated content.

This license applies to all textures, meshes, models, materials, wording, phrases and logos/trade marks in association with Angel Rae's Textures. Upon purchasing/downloading textures you are by default agreeing to this license.

You, the customer, are purchasing the legal right to use the content in accordance with this license, not the content itself. You do not become the legal owner of any content you download from the Angel Rae's Textures website and/or purchase from the official associated stores and franchises. The intellectual rights of content displayed on this website remains the property of Angel Rae's Textures and the registered merchants before, during and after any purchase and/or download.

Please note, you are not licensed to use content originating from Angel Rae's Textures unless you have purchased said content (and by default obtained the legal right to use it) directly from any of our official stores/websites.

For accounting purposes, we hold records of all purchases made from this website, our Second Life in-world store and other official third party websites and franchise outlets.

If in doubt, please ask, we are happy to assist you in obtaining the correct license for textures you may hold in your inventory but are unable to recall where or how you obtained it. We understand people often obtain Angel Rae's Textures from unofficial sources and usually in innocence or ignorance. Our aim is not to "point fingers and punish" but to ensure people are confident the content they are using is licensed for such use and to prevent unnecessary DMCA administration.

We would much prefer to spend our time creating content and helping customers than filing DMCA Take Down Notices if it can be avoided.

CONDITIONS OF USE - Second Life License

Use of the Textures/content is only allowed under the following conditions:

Textures purchased by Linden Dollar and delivered within the virtual world of Secondlife.com are licensed for use within Secondlife.com only.

- You may sell and transfer anything you create using textures from Angel Rae's Textures. You may sell anything you create using the content but not the content in its original format. For example, you may not redistribute textures "as" texture files. This would be seen as an act of direct competition and in breach of our User License.
- You may save Angel Rae's Textures to one computer in order to modify/edit for personal and commercial content creations within the Second Life environment. This includes clothing design, building and prim/mesh/model creation. You may also sell anything you create using the modified textures but not the modified content in its native format. Example: You may not redistribute modified/edited textures "as" textures. This would be seen as an act of direct competition and in breach of our User License.

You are NOT permitted to:

- You cannot distribute, sell, giveaway, or share content from Angel Rae's Textures, in or outside of Secondlife.com
- This includes: in world stores (from any online platform) in world vendors, 3rd party websites and platforms, burning to CD or DVDs, sharing on your own blog/website, third party websites, torrent or P2P websites, sharing with group members, friends or customers, sharing in "Texture Sharing Groups" within secondlife.com and other third party platforms.
- You cannot export or extract content out of Secondlife.com as texture files (or applied to pre made builds/meshes) using applications such as SecondInventory or other "texture exporting software" · You cannot save to your computer to modify to any degree with the sole intention of reselling or redistributing the textures. This license does not allow modification of our artwork for distribution purposes alone.
- As of the 6th Oct 2010 the Terms Of Service for Secondlife.com was amended to include the following:

7. CONTENT LICENSES AND INTELLECTUAL PROPERTY RIGHTS

7.8 You agree to respect the Intellectual Property Rights of other users, Linden Lab, and third parties. {You agree that you will not copy, transfer, or distribute outside the Service any Content that contains

any Linden In-World Content, in whole or in part or in modified or unmodified form, except as allowed by the Snapshot and Machinima Policy, or that infringes or violates any Intellectual Property Rights of Linden Lab, other Content Providers, or any third parties.}

By breaching our User License you would also, by default, be breaching the secondlife.com TOS and as such your Secondlife.com account may be suspended or banned.

CONDITIONS OF USE - Any World License

Use of the Textures/content is only allowed under the following conditions:

- This license allows you to use Angel Rae's Textures content in all virtual worlds and 3D social platforms, including Secondlife.com
- If you have a specific purpose in mind and have questions about whether this license applies to it please send your question to loveangelrae resident
- You can sell or give anything you create using Angel Rae's Textures purchased from Angel Rae's Textures website (via paypal) You can sell anything you create using the content but not the content in its original native format. For example, you cannot redistribute textures 'as' textures. As long as they are applied to a build/mesh/model, you may distribute and profit from your end product. You may save copies of textures to one computer in order to modify/edit for personal and commercial content creation. This includes clothing design, building, meshes and models. You can sell anything you create using modified content, but not the modified content in its original native format. For example, you cannot redistribute textures or meshes you have edited or modified "as" textures or meshes. This would be seen as an act of direct competition and in breach of our User License.

You Are NOT permitted to:

- You may not distribute, sell, giveaway, or share any content in its original native format (textures 'as' textures) in or outside the Secondlife.com environment. This includes (but is not limited to) in-world stores, vendors, third party websites, torrent websites, P2P websites, personal or third party blog sites, burning to CD/DVD, sharing on your own websites, sharing with group members, friends and customers.
- You may not save to your computer to modify the content to any degree with the sole intention of redistributing for free or profit, said content in its original native format (textures "as" textures) This would be seen as an act of direct competition and in breach of our User License.

CONDITIONS OF USE - Extended License

Use of the content under the Professional License is only allowed under the following conditions:

- Private or commercial use
- Use in virtual worlds

- Use of Scrap Book creation where artwork is to be printed on physical goods such as gift cards, greeting cards, calendars and photo frames (and any other "physical" or printed content)
- Use in magazines, books and advertising publications and all other printed media. This includes commercial usage.
- Use in movies
- Incorporation in computer games, 3D models where the original content is not packaged separately or as part of the end product. (Your end user must not have direct access to any of content originating from Angel Rae's Textures)
- Selling 3D models/meshes bundled with modified versions of artwork and/or textures, when the content is customised for the 3D model (your customers must not have direct access to any modified or unmodified content created by using Angel Rae's Textures textures, meshes, sculpt maps)
- Use in educational establishments for training and teaching of graphic design and related digital art or design classes.

You Are NOT permitted to:

- Sell or distribute any of content/artwork in its unedited or original format, or where the derived product you are selling or distributing is a Texture or a collection of Textures.

To Clarify: You cannot sell or distribute any textures (or meshes) modified or not, by itself or in a texture, material, clipart or scrap booking packs. You cannot bundle the content with software such as paint programs, 3D programs, photo-kiosk software. Reselling textures as 'print on demand' services (mugs, t-shirts, mouse mats, etc)

- Selling skins for laptops, phones and other devices, created with content from Angel Rae's Textures
- Release the content or derivative content under Open Source Licenses
