

END USER LICENCE AGREEMENT

As a partner, you are aware of the fact that we will always try to be fair, look for a better way for manage the affiliate program that we provide.

We protect our intellectual property from unscrupulous use and manage our ongoing maintenance through updates and other changes.

DEFINITION OF TERMS

Partner (distributor, reseller, affiliate): a user who buys or uses products from the service provider and receives a commission in accordance with the terms of the affiliate program.

Service provider - Skifija: products or services seller, interested in expanding the market through the creation and development of the affiliate program.

The third person: a person who is not the Partner nor the Service provider

Commission: remuneration (fixed amount or percentage) that you receive in accordance with the terms of the affiliate program.

Contract: This license agreement with the end user

Permissions: Second Life's permissions system

Service Provider's Rules: Terms of Service

CONCLUSION OF A CONTRACT

By purchasing our products as Partner, you establish a contract with the Service provider. The terms of this contract are described by the License Agreement.

All products are considered "user licensed." The license terms are described by the user license agreement.

This applies to all products from the service provider. The buyer is required to read this agreement. No buyer can become a partner without entirely accepting this agreement.

PRIVACY AGREEMENT

Confidentiality agreement exists between the partners, and services providers.

If the Partner sells the products to a third party, the contract remains between the Partner and the Service Provider.

The agreement does not concern third parties, regardless of the permissions in the settings of the product.

Liability for improper sale will be applied to the partner who sold the goods to a third party, rather than a Service provider.

INTELLECTUAL PROPERTY

The service provider retains all intellectual property rights associated with the products sold.

Partner is granted a license to obtain and use the services provided by the Service Provider for the purchased product.

TERMINATION / TERMS AND CONDITIONS

The Service Provider will provide the service for Partners, as described in the product information. This agreement may be terminated due to the Partner's misuse of the product, other unexpected events at the discretion of Service Providers, as well as other circumstances beyond the control of the service provider. The provision of all products and services will be terminated immediately if the Service Provider ceases to operate in Second Life.

However, Skifija has operated in Second Life for a considerable period of time, so this should not be considered as a significant risk when purchasing any of our products.

Partner agrees to abide to the Terms of Service.

Terms of Service are subject to change at any time and will be applied to all products.

Service Provider reserves to himself the exclusive right to make changes to any product at any time. Free updates will be provided to all existing products in the absolute discretion of the Service Provider.

REFUND CONDITIONS

No refund.

The service provider reserves to himself the right to provide compensation to a buyer, if he considers it as appropriate, and at his absolute discretion.
